

Xtreme Courage Fighting Championships Amateur Fight Contract

This agreement made and entered into this _____ day of _____, 2008 between Xtreme Courage Fighting Championships, of Clifton, Arizona, a mixed martial arts promoter, herein after called "promoter", and _____ (**Fighter's Name**), herein after called, "fighter", follows:

1. The fighter agrees to appear and engage in an amateur mixed martial arts contest, scheduled for 3 rounds of 3 minute duration for a non-championship fight, or 5 rounds of 3 minute duration for championship fights, at a weight of _____. The fight will be held on _____, 2008, at _____ (Name of Venue), in _____ (Town), _____ (State).

2. "Fighter" agrees his participation in the bout shall be an honest exhibition of his abilities as a mixed martial artist.

3. **Liability release:** "Fighter" understands there is an "assumed risk associated" with mixed martial arts, and understands mixed martial arts, is a contact sport and in the event of physical injury, death or personal loss occurs will hold harmless promoter and its employees.

4. **No-Show Clause:** If "fighter" fails to show up for scheduled bout, fighter will be held financially responsible by "promoter". A "no show" fee of \$250.00 will be charged to "fighter" with payment due to "promoter" within 10 days of original bout date listed herein. If "fighter" neglects to pay said fee he shall be prosecuted accordingly in New Mexico, in a New Mexico claims court. Along with said fee "fighter" will also be held accountable for all reasonable court and attorney fees and costs. The following circumstances may be an excuse for breaking this contract, but you must provide written documentation of occurrence; death of immediate family member, activation to military service, an injury that bars you from competing.

*Immediate family member is defined as a spouse, sibling, child, or grandparent.

*Injuries must be documented by a physician's statement prior to the bout.

5. **Talent Release:** The "fighter" agrees to allow his image (including video) to be used for XCFC media products (posters, publications, DVD's, website, etc...) without any financial compensation. All images/video are the sole property of "Rep's Fightography".

6. **Championship Clause:** The "fighter" who wins a belt in a championship fight agrees to defend this title within 4 months of acceptance. And understands that if a XCFC title challenge is not accepted within 4 months of winning the belt, then the title is relinquished and the belt must be returned immediately to Mr. Shane Dunagan or an agent of his choosing. The belt is the sole property of Xtreme Courage Fighting Championships.

7. **Medical Clause:** The "fighter" promises to have the required medical tests completed by two weeks before the fight date or a \$250 penalty fine will be charged to "fighter" with payment due to "promoter" within 10 days of original bout date listed herein. Required medical testing is defined as HIV, Hepatitis B and hepatitis C.
